



## **RULES & REGULATIONS**

Only 115,000 tickets will be printed.

### **GENERAL RULES**

Only ONE method of payment will be accepted.

Only ONE mailing address will be recorded.

Hospital Home Lottery tickets, 50/50 Add-On tickets and 100 Days of Winning Cash Calendar Add-On tickets will be mailed separately.

Persons must be 18 years of age to purchase a ticket and the name of a person under 18 years of age may not be written on the ticket.

Only tickets that have been paid for, and verified as paid for, are eligible for the respective draw(s). All inquiries regarding the chances of winning and method of awarding prizes can be made to the licensee by phoning toll free at 1-833-208-4388.

The following, including their spouse and any related or dependent person residing in the same household, are prohibited from purchasing a ticket: Calgary Health Trust employees, Board members and Development Council members, the raffle manager and their employees, and the partners and employees of the professional services firm of Deloitte LLP.

Tickets may only be sold and purchased within Alberta. Restrictions apply. If your ticket contains an error, please call toll free at 1-833-208-4388.

All ticket purchases are final, and refunds are not available. 3,006 prizes will be awarded. All prizes awarded are new product. Prizes awarded may not be exactly as illustrated.

◆ Each Hospital Home Lottery ticket in a 3-pack, 5-pack or 8-pack, each 50/50 Add-On ticket in a 5-pack or 15-pack, and each 100 Days of Winning Cash Calendar Add-On ticket in a 3-pack or 6-pack and Max Pack tickets must contain the same name and contact information. Prizes must be accepted as awarded.

Retail values are approximate as of date contracts were negotiated with suppliers. Due to housing market fluctuations, the market value of the real estate prizes may rise or diminish over time. The winners will be contacted in writing every day from December 1, 2019 to March 9, 2020, by the professional services firm of Deloitte LLP as to what they have won and how to claim their prize.

After each draw, the winner's name and ticket number are recorded and the ticket number remains eligible for all subsequent draws.

#### **DRAW ORDER**
